When it comes to foreclosure, waiting around before getting help is a bad strategy. This FREE Workshop will educate homeowners who are behind on their mortgage payments on what to do to avoid Foreclosure.

Experts from banks, the US Dept. of HUD, and several nonprofit housing and legal organizations will participate and provide one on one counseling and other assistance for families worried about or experiencing foreclosure. Housing counselors will be available to confidentially meet one on one to offer free advice and answer questions. A short presentation on how to negotiate with lenders and/or loan servicers to prevent and avoid foreclosure will also be provided. Bring your loan documents and meet with lenders who will be doing loan workouts on site.

This FREE Foreclosure Prevention Workshop is a community service program of the Orange County Homeownership Preservation Collaborative (OC HOPC), a coalition of nonprofit organizations, lenders, US Department of Housing and Urban Development, local cities and housing agencies in Orange County.
